Sub. : Awareness in respect of Ban on Sharp Manja in GNCT of Delhi – reg.

It is to inform you that kite flying is popular sport and it catches pace weeks before, during and after the Independence Day every year.

However, kite flying by using thread made out of plastic, nylon or similar such synthetic material including popularly known "Chinese thread/ manja" or any other thread coated with glass/ metallic components causes a lot of injury to human beings and birds which many a times turns out to be fatal. Such deaths and incidents have been seen in the news also during the last few years. Apart from this, such kite flying threads being non-biodegradable also cause harm to the environment.

Therefore, in order to prevent the adverse effects on human beings, cattle population, birds, soil and ecology, Hon'ble Lieutenant Governor of the National Capital Territory of Delhi, has issued a Notification on 10.01.2017 with the following directions:-

1. There shall be complete ban on the sale, production, storage, supply, import, and use of kite flying thread made out of nylon, plastic or any other synthetic material including popularly known as "Chinese manja" and any other kite-flying thread that is sharp or made sharp such as by being laced with glass, metal or any other sharp materials in the National Capital Territory of Delhi.

2. Kite flying shall be permissible only with a cotton thread, free from any sharp/ metallic/ glass components / adhesives/ thread strengthening materials.

Further, the violation of directions issued under section 5 of the Environment (Protection) Act, 1986, or the rules made thereunder shall be punishable under section 15 of the said Act which include imprisonment upto five years and / or with fine which may be extended to Rs. One Lac or with both.

**Subject- Ban on sharp synthetic/nylon kite flying thread including popularly known "Chinese Manjha"**

This is for the information of the general public that in order to prevent the adverse effects on human beings, cattle population, birds, soil and ecology and in exercise of the powers conferred by section 5 of the Environment (Protection) Act, 1986 (29 of 1986) read with Government of India, Ministry of Home Affairs' Notification No. SO 667 (E), dated 10<sup>th</sup> September, 1992, a Notification was issued on 10.01.2017 by order and in the name of the Hon'ble Lt. Governor of the NCT of Delhi with the following directions:

1. There shall be complete ban on the sale, production, storage, supply, import, and use of kite flying thread made out of nylon, plastic or any other synthetic material including popularly known as "Chinese manja" and any other kite flying thread that is sharp or made sharp such as by being laced with glass, metal or any other sharp materials in the National Capital Territory of Delhi.
2. Kite flying shall be permissible only with a cotton thread, free from any sharp/ metallic/ glass components / adhesives/ thread strengthening materials.

विषय - पतंग उड़ाने वाले तेज धारदार सिन्थेटिक/नायलॉन धागे जिनमें लोकप्रियता से जाना जाने वाला चीनी माइला भी शामिल है - पर प्रतिबंध

जनसाधारण को सूचित किया जाता है कि मानवता, पशुधन, पक्षी और पारिस्थितिकी पर होने वाले दुष्प्रभाव को रोकने के लिए तथा गृह मंत्रालय भारत सरकार की दिनांक 10 सितम्बर 1992 की अधिसूचना सं. एसओ 667 (ई) के साथ पठित पर्यावरण (संरक्षण) अधिनियम, 1986 (1986 का 29) की धारा 5 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए राष्ट्रीय राजधानी क्षेत्र, दिल्ली के उपराज्यपाल के नाम पर तथा आदेश सं 10/01/2017 को अधिसूचना जारी की गई है, जिसके तहत निम्न निर्देश दिए गये हैं।

- 1) नायलॉन, प्लास्टिक अथवा अन्य किसी सिन्थेटिक सामग्री से विनिर्मित पतंग उड़ाने वाला धागा जिसमें कि चीनी माइला के नाम से प्रसिद्ध तथा ऐसे अन्य पतंग उड़ाने वाले धागे जो धारदार हैं या शीशे, धातु या अन्य धारदार सामग्री से लेपित कर पतंग उड़ाने के लिए बनाए जाते हैं, ऐसे पतंग उड़ाने वाले धागों की राष्ट्रीय राजधानी क्षेत्र दिल्ली में बिक्री, उत्पादन, भण्डारण, आपूर्ति, आयात एवं प्रयोग पर पूर्णतः प्रतिबंध होगा।
- 2) केवल सूती धागे, जो कि किसी धारदार धातु/शीशे के घटकों/चिपकाने वाले पदार्थों/धागे को मजबूत बनाने वाली सामग्रियों से रहित हैं, उन्हीं से पतंग उड़ाने की अनुमति होगी।
