CIRCULAR

Sub: Regarding Vaccination of Students of age group 12 to 14 years.

As per directions received from Secretary, GoI, Department of Health and Family Welfare, Ministry of H&FW vide D.O. No.P-2317579/2021/Imm Dated: 14.03.2022 COVID-19 Vaccination of children in the age group of 12-14 years has to be started from 16th March 2022. For such beneficiaries, option for vaccination would only be available for CORBEVAX.

COVID-19 vaccination of children in the age group of 12-14 years is to be started from 16th March 2022. Only CorBEvax vaccine would be used for the beneficiaries of age group 12-13 and 13-14 years (those born in 2008, 2009 and 2010. i.e. those who are already above 12 years of age). Beneficiaries between 14-15 years have already been covered in the vaccination for 15-18 years' age group.

Keeping this in view the evolving situation of the Covid-19 pandemic and the emerging evidence, the expert group has decided to expand Covie-19 vaccination program to children aged 12 to 14 years from 16th March 2022. Only CorBEvax would be used for these beneficiaries in the age group of 12 to 13 years and 13-14 years in government CVCs in view of vaccine security issues and limited availability of other Covid-19 vaccines approved for this age group.

Directorate of Education is committed to take all necessary measures to safe guard the health of students studying in schools under DoE.

On the basis of above, all HoS have an important role to playing in ensuring proper coverage of this vaccination drive. All HoS may be directed to observe the following:

- 1. Vaccine will be administered to only those children who have attained the age of 12 years on the date of vaccination.
- 2. Direct the Nodal In-charge of the school to coordinate this activity too.
- 3. All beneficiaries born in year 2010 or earlier i.e. those who have already attained age of 12 years as will be able to register on Co-WIN. The vaccination slots will be booked for 12-14 years age group for "CorBEvax" only through Co-WIN.
- 4. Vaccinator has to unsure that vaccine is administered to only those children who have attained age of 12 years on the date of vaccination and if a child is registered but not attained age of 12 years the vaccination is not to be given.
- 5. Registration can be done through the following modes:
 - Self –registration through an existing account on Co-WIN of a family member or by creating a new account through a unique mobile number (this facility is available for all eligible citizens presently).
 - Onsite registration by the vaccinator in facilitated registration mode.
- 6. Appointment can be booked online or onsite (walk-in) for 12-14 years. For such beneficiaries, option for vaccination would only be "CorBEvax"

- 7. Vaccination of 12-14 years would be conducted through dedicated vaccination sessions (i.e. earmarked COVID-19 Vaccination Centers for vaccination of 12-14 years' age –group) to avoid their unintended vaccination with any other COVID-19 vaccines.
- 8. Class Teachers of the relevant classes/sections must ensure that parents are informed to take their children to nearest vaccination site earmarked for vaccination of children between 12 to 14 years of age.
- 9. In case the school itself has been identified as a CVC for 12 to 14 age group, parents may accompany the children to the school & facilitation in terms of provision of separate room, staff for queue management & verifier should be provided by the Head of the Schools.
- 10. In addition, if the school is not a CVC, but a temporary camp mode vaccination of its students of this age group is required, the Head of the School will get in touch with the District Immunization Officer so that a mobile team can be positioned for sufficient days depending upon the number of children to be vaccinated. The children can be informed and mobilized to school on the designated days. Head of the School will provide the necessary space, staff for queue management, verifier and computer/internet connectivity for these days.
- 11. In case of private schools, the Head of the Schools may get in touch with the private/Govt CVCs to provide school-based camp mode vaccination of their children with due observance of Government operational guidelines for CVCs.
- 12. List of all COVID-19 vaccination centers/session sites earmarked for this age group in 12 to 14 years shall be published and updated on website of Delhi State Health Mission (www.dshm.delhi.gov.in).
- 13. DDE (Districts) and DDE (Zones) are directed to ensure the compliance of the above directions & will also ensure that each head of the school must upload the status of vaccinated students as per below mentioned schedule.
- 14. All DDE (Districts) and DDE (Zones) are also directed to upload the vaccination status of their Districts in consolidated form and also School wise on a) DoE Whatsapp group and also on b) <u>healthschoolbranch@gmail.com</u> by 04:30pm daily including Saturday and Sunday.

The National COV4D-19 Vaccination Program has covered 95.5% of the eligible population (15 years and above) with at least one dose of COVID-19 vaccine while more than 80% of the eligible beneficiaries are fully vaccinated. More than 180 crore vaccine doses of COVID-19 vaccine have been administered. This mammoth task has been made possible with the active support from States/UTs. Precaution dose is also being administered to the Health Care Workers, Front Line Workers, and 60 years and above age group with comorbidities since 10th January 2022.

2. National COVID-19 vaccination program has continuously been guided by scientific evidences and global best practices. On the recommendation of the experts it has now been decided to further expand the coverage of COVID-19 vaccination as follows:

- a) COVID-19 vaccination of children in the age group of 12-14 years to be started from 16th March 2022. Only Corbevax vaccine would be used for the beneficiaries of age group 12-13 and 13-14 years. Beneficiaries between 14-15 years have already been covered in the vaccination for 15-18 years' age group.
- b) Precaution dose can now be provided to all persons of 60 years and above age. The prioritization and sequencing of this precaution dose would be based on completion of 9 months i.e. 39 weeks from the date of administration of second dose. Vaccination of precaution dose should be with the same vaccine with which primary vaccination was done(homologous).

All citizen irrespective of their income status are entitled to free COVID-19 vaccination at Govt. Covid Vaccination Centers. Doses of all three vaccines being used under the National Covid Vaccination Programme i.e Covisheild, Covaxin and CorBEvax are available in sufficient quantities in the States/UTs.

3. A detailed guideline prepared for vaccination of children of 12-14 years is annexed (Annexure-1). As CorBEvax vaccine is approved only for those above 12 years of age, it should be ensured that children who are above 12 years of age only, are vaccinated i.e. those who are born on or before 15th March 2010. The vaccinator and verifier should ensure that beneficiaries less than 12 years on the date of vaccination are not vaccinated even if he/she is registered on CoWIN.

4. The State/UTs wise projected number of 12-14 years age group provided by Registrar General of India (RGI) is annexed (Annexure-2). The State/UT wise projected number of 60 years and above age group provided by Registrar General of India is also annexed (Annexure-3).

5. I look forward to your continuous support in this endeavor to effectively address the pandemic.



Guidelines for COVID-19 vaccination of children between 12-14 years of age

India's National COVID Vaccination Program is built on scientific and epidemiological evidence, WHO guidelines and global best practices. The program started with the vaccination of health care workers (HCWs) and frontline workers (FLWs). The program ambit expanded in a phased manner, with the inclusion of all individuals aged 18 years and above from 1st May 2021. The program coverage was further expanded to children 15 to 18 years of age from 3rd January 2022 and administration of precaution dose to HCWs, FLWs and people aged 60 +years with comorbidities based on medical advice from 10th January 2022.

Keeping in mind the evolving situation of the Covid-19 pandemic and the emerging evidence, the expert group has decided to expand Covid-19 vaccination program to children aged 12 to 14 years from March 2022. Only CorBEvax would be used for these beneficiaries in the age group of 12 to 13 years & 13-14 years in government CVCs in view of vaccine security issues and limited availability of other Covid-19 vaccines approved for this age group.

Operationalization

As the 12 to 14 years' age group constitutes school-going children, complimentary strategies may be formulated to ensure vaccination of all eligible beneficiaries in this age group, irrespective of whether they are enrolled in state/central government schools, aided/unaided private schools or other nonformal schools like madrasas etc. are covered with strict adherence to the operational guidelines for Covid19 vaccination.

Management and reporting of AEFIs will be as per existing guidelines. Anaphylaxis kits must be available with each vaccination teams.

Vaccine will be administered to only those children who have attained the age of 12 years on the date of vaccination. The vaccinator and verifier will be responsible to ensure that any beneficiary aged less than 12 years on the date of vaccination is not vaccinated with special attention to those born in 2010.

Recording and reporting of vaccination for this age group will be on CoWIN as per the existing guidelines.

Co-WIN features and provisions for beneficiaries aged 12-14 years:

- 1. All beneficiaries born in year 2010 or earlier i.e. those who have already attained age of 12 years as will be able to register on CoWIN. The vaccination slots will be booked for 12-14 years age group for "CorBEvax" only through Co-WIN.
 - 2. Vaccinator has to ensure that vaccine is administered to only those children who have completed the age of 12 years on the date of vaccination and if a child is registered but not attained age of 12 years the vaccination is not to be given .

- 3. Registration can be done through the following modes:
 - Self-registration through an existing account on Co-WIN of a family member or by creating a new account through a unique mobile number (this facility is available for all eligible citizens presently).
 - Onsite registration by the vaccinator in facilitated registration mode
- 4. Appointments can be booked online or onsite (walk-in) for 12-14 years. For such beneficiaries, option for vaccination would only be "CorBEvax"
- 5. Vaccination of 12-14 years would be conducted through dedicated vaccination sessions (i.e. earmarked COVID-19 Vaccination Centers for vaccination of 12-14 years' age-group) to avoid their unintended vaccination with any other COVID-19 vaccines.
